#75-09 WATER RATE RESOLUTION

WHEREAS, in compliance with Section 10, Bessemer Township *Water Rate Ordinance W-3*, the Township Board finds it necessary to review and revise the rates established to provide for payment of the expenses of administration, operation and maintenance of the Bessemer Township Water System.

WHEREAS, the rate per month for the services furnished by the Bessemer Township Water System shall be set at:

Residential 3/4 inch meter: readiness to serve charge:	\$30.00
Residential 3/4 inch meter: commodity (0 -1000 gallons).....	\$6.50
Residential 3/4 inch meter: (for each 1000 gallons of use).....	\$6.50

Commercial Readiness to serve:

3/4 inch meter.....	\$35.00
1 inch meter.....	\$45.00
1 1/2 inch meter.....	\$50.00
2 inch meter.....	\$100.00
3 inch meter.....	\$880.00
4 inch meter.....	\$1,400.00
