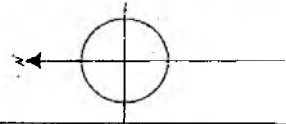

 The land embraced in the annexed plat consists of the North-west one-quarter (1/4) of the South-east one-quarter (1/4) of Section Thirteen (13) Township Forty-seven (47) North Range Forty-six (46) West, and is described as follows:  
 Commencing at an iron pipe at the centre of Section 13, thence N0°20'E 1318.86 thence S0°18'W 1318.30 thence N89°25'W 1316.90 thence N0°20'E 1316.1 to place of beginning.

I hereby certify that the plat hereon delineated is a correct one, and that permanent monuments consisting of 1 1/2" iron pipes 3ft. long have been placed at all points marked thereon, as hereon shown at all angles in the boundaries of the land platted and of all intersections of streets and alleys.

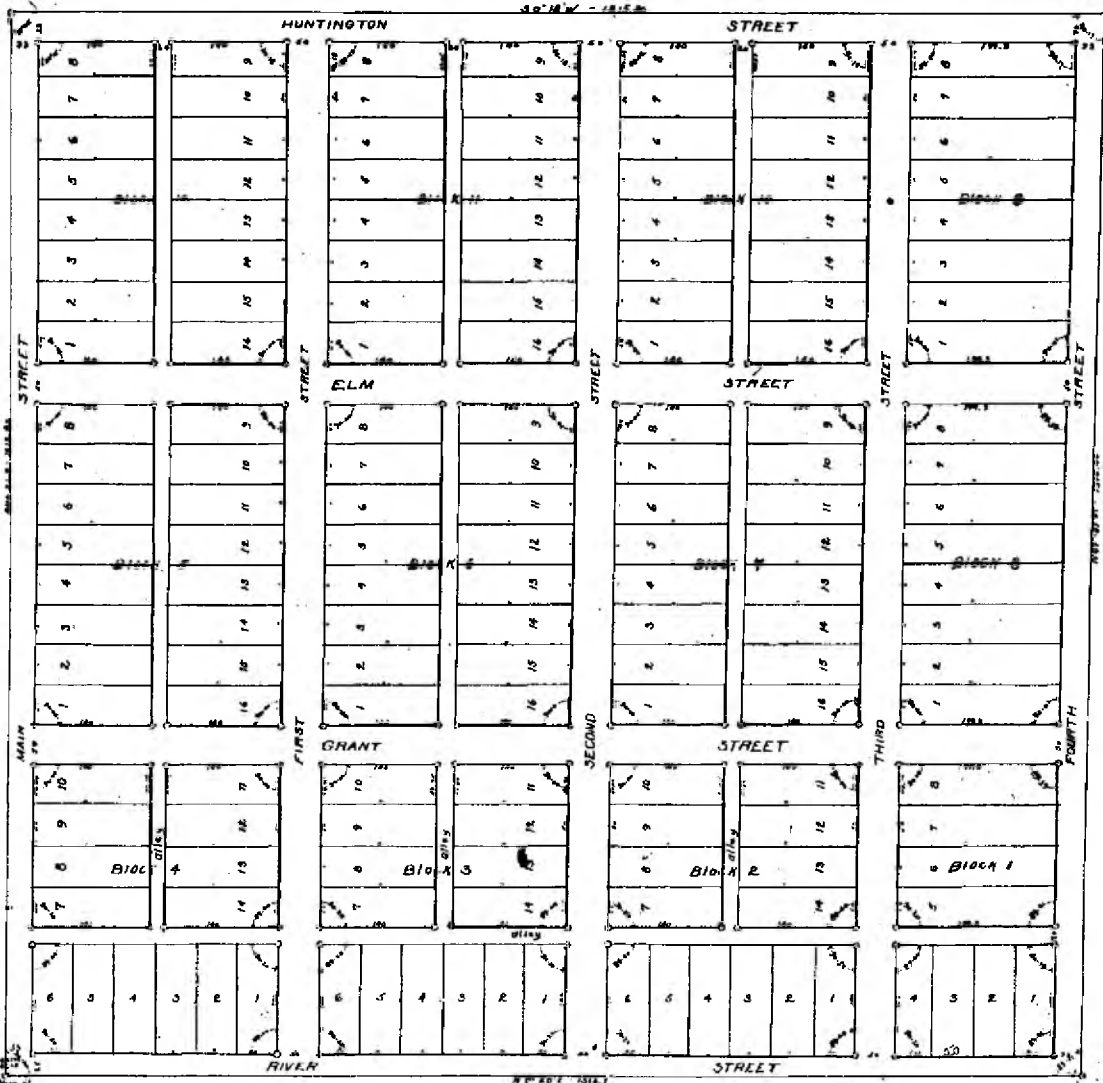
