REPORTS-BOARDS, COMMITTEES, ETC.

- a. GRWA: City of Wakefield has appointed Mike Grayson as a new alternate member. Bob Blaskowski remains as their current representative, and John Granato as their member at large. Current projects are in progression mode. Powdermill Creek pump station was approved for paving due to weeds and plowing issues. Northwoods Paving will complete the work.
- b. BASA: City of Bessemer manager visited the plant. Planned improvements include a new roof and windows. Reports staff is motivated and engaged.
- c. Bessemer Township 4th of July Committee: Committee is wrapping up from the holiday celebration. Board extends congratulation and appreciation on a spectacular job. BTVFD hosted the CIRCUS at the park on 7/13/14. Ticket sales were soft for the first event, but profit was still realized of \$173. Discussion was had on how to better market the event next year. Suggestions included tying in marketing with advertising during the 4th of July festivities. Supervisor Randall reported the BTVFD realized \$567.00 from liquor sales during the 5th of July activities.
- d. Roads: Work has begun on various roads per maintenance schedule. Discussion was had.
- e. Blight: Structure was burned in Anvil Hill location. Work continues on cleanup effort.
- f. MTA: Meeting changed from original scheduled date to July 29th. Bessemer Township is host with a planned potluck in the Ramsay Park. New District 1 representative will be present. Meeting scheduled to begin at 6:00 pm CST.
- g. Beautiful print of the Ramsay Park featuring the Eureka 4 Mine was donated to the township from Debbie Maki, local business owner of the Keystone Bar for several years. Debbie recently sold her business, and wanted to ensure that the historical print had a good home. The board extends their appreciation on behalf of the entire Township for her gift, and will display the print in the Township Hall.

NEW BUSINESS

a. USDA/RD SEWER BUDGET: Discussion was had, and presentation of Ramsay Sewer rates and related issues were presented with Mr. Randy Scott. Process includes certification that the maps are correct, signatures by the supervisor and clerk, corporate seal affixed to said documents, and forward of such to the atty. Atty then signs the opinion to record that the proper right of ways are in place for the project. Final process forwards all to the USDA. Discussion was had. MOTION by Grenfell, support by Tarnaski to approve the maps as presented attesting location of ROW on map as correct, and authorize signatures as such. MOTION by Grenfell, support by Tarnaski.
