REPORTS - BOARDS & COMMITTEES

COMMUNITY DEVELOPMENT BLOCK GRANT-On August 4th there will be a construction meeting with Cathi Cole. The project will include much of River Street, 4th, and Londo Road south.

ROAD CONSTRUCTION - Paving on Grant, Geneva and Harding road have begun with pulverization. They will also be chip sealed.

RAMSAY SEWER CONSTRUCTION PROJECT –Major construction should be down within the next two weeks, and then restoration will begin.

POWDERHORN AREA UTILITY DISTRICT – The Supervisor reported that this was a regular business meeting.

GOGEBIC RANGE SOLID WASTE MANAGEMENT AUTHROITY –Tipping fees have been reduced from \$120 to \$108 per ton. This is being done on a two month trial. Members have been reimbursed for their contribution for the debt payoff. A discussion was had regarding the City of Bessemer's request to pull out of the authority. According to an outside CPA review of the accounts the City is still obligated to contribute.

SNOW MOBILE TRAIL – It has been noted that the area around Plymouth Lake that is private property will not be accessible by snowmobile. This will redirect snow mobilers to come through

Ramsay Crossing and go across US2. The board discussed safety issues. The Supervisor will be talking with the Road Commission.
